AMCO Updates

 New Title 4 and accompanying regulations become effective 1/1/24

- Alaska Statute 4 (AS 04 or Title 4)
- 3 AAC has been amended to repeal chapter 304 and replace with 305 (3 AAC 305)



AMCO Updates

Regulations:

- ABC board, AMCO staff, and industry stakeholders have rewritten regulations and will be found in 3 AAC 305
- 8 out of 9 articles of regulation have been approved by board and Lt. Governor and will be effective 1/1/24



AMCO Updates

New online licensing system:

- State of Alaska has contracted Gov2Biz to develop an online system for alcohol and marijuana licensees
- AK-ACCIS went live in September 2023
- Portal for licensees (not local governments)





Why did Title 4 need to be rewritten?

- Last significant update to Title 4 was in 1980
- In many ways it was considered outdated, confusing or otherwise ineffective
- Stakeholders from across the state representing the alcohol industry, public health, local governments, law enforcement, public safety, education, and community advocacy sectors crafted recommendations to legislature



Goals of the Title 4 Rewrite

- Create rational regulation for all tiers of the state's alcohol industry
- Limit youth access to alcohol while ensuring youth are not criminalized
- Promote responsible alcohol use and reduce the harms of overconsumption

- Increase swiftness, proportionality, and consistency of penalties
- Increase local law enforcement of Title 4
- Increase licensee accountability before the ABC board for Title 4 violations



Upcoming changes and highlights

1. Some changes have already taken place:

- Public convenience licenses have been replaced with REPLs
- Local Governments who qualify may request additional REPLs

2. Effective January 1, 2024:

- Endorsements go into effect (for both existing and new privileges)
- Reorganized licensing system and new fees
- New penalty structure for minor offenses
- Regulating internet sales and direct shipping



Licenses, Endorsements, Permits

Defining Terms:

- **License:** A license defines activities allowed daily on licensed premises. License type is a general category of license activity based on a three-tier system of alcohol regulation: manufacturer, wholesale, and retail.
- **Endorsement:** An endorsement expands the boundaries of a licensed premises or the authorized activities of a licensed business
- Permit: A permit allows catering and serving activities for a specific period of time on a single specified premises and allows an eligible nonprofit organization to host a fundraising or not-for-profit event.



Alcohol Licenses

License types going away 1/1/24:

Bottling Works; Brewpub; Brewery; Distillery; Winery;
 Public Convenience; Duplicate Beverage Dispensary;
 Retail stock sale license

New license types available 1/1/24:

 Brewery Manufacturer; Distillery Manufacturer; Winery Manufacturer; Brewery Retail; Distillery Retail; Winery Retail; Manufacturer Direct Shipping



Automatic conversions of licenses

- Bottling Works or Brewpub licenses > brewery or winery manufacturer
- BDL or REPL that is a theater > Theater License
- Wholesale license > either a General Wholesale or Limited Wholesale Brewed Bev. & Wine

- Duplicate BDL > Multiple Fixed
 Counter Endorsement
- Brewery/ Winery/ Distillery > Brewery/ Winery/ Distillery Manufacturer

however...

 They must <u>apply</u> for the Brewery/ Winery/ Distillery <u>Retail license</u>



Conversions of licenses upon application

 Recreational Site License > Sporting Activity or Event License upon application

 Restaurant Designation Permit > Restaurant Endorsement upon application



Add endorsements to existing licenses, giving businesses flexibility in how to operate, without creating more specific license types.



ENDORSEMENTS

Expanded activities and/or premises to fit business model

Endorsements will allow sampling on premises, multiple bar rooms, deliveries by package stores, etc.

* automatic conversion



 An endorsement is valid only in conjunction with a license. An endorsement may be transferred to another person only if the license for which the endorsement was issued is also transferred to that person

 An endorsement expires if the licensed premises are relocated, the license expires, or the license is revoked



AS 04.09.420 – Multiple Fixed Counter Endorsement

- ... authorizes the holder of a BDL or BDL-Tourism to sell or serve alcoholic beverages on the licensed premises from multiple fixed counters.
- Only necessary if a duplicate license was required
- This endorsement replaces the Duplicate Beverage Dispensary license



- AS 04.09.410 Manufacturer Sampling Endorsement
 - ... authorizes the holder of a brewery/ winery/ or distillery <u>manufacturer</u> license to offer for consumption on the licensed premises at no charge a small sample of an alcoholic beverage produced by the manufacturer.
 - Brewery Manufacturer
 - 12 oz. of beer
 - 6 oz. of sake
 - Winery Manufacturer
 - 6 oz. of wine
 - 12 oz. of mead/ cider

- Distillery Manufacturer
 - 1.5 oz. (may include n/a mixer)



• AS 04.09.430 – Hotel or Motel Endorsement

... authorizes the holder of a BDL or BDL-Tourism that is a hotel, motel, resort, or similar business that caters to the travelling public as a substantial part of its business to sell or serve alcoholic beverages on the licensed premises, including in a dining room, banquet room, and other public areas approved by the board, and in guest rooms.



- AS 04.09.450 Restaurant Endorsement
 - ... authorizes the holder of a *BDL*, *fair license*, *golf course license*, *sporting activity or event license*, *club license*, *outdoor recreation lodge license*, *destination resort license*, *or BDL-Tourism* to allow a person under 21 years of age access to the premises of a bona fide restaurant
 - The board may issue an endorsement only if they find:
 - the establishment is a bona fide restaurant
 - There is supervision on the premises adequate to reasonably ensure that a person under 21 will not obtain alcoholic beverages
 - Endorsement allows a person who is at least 16 but under 21 to enter and remain on premises for dining only



AS 04.09.460 – Package Store Shipping Endorsement

- ... authorizes the package store licensee to sell alcoholic beverages to a person who makes a written or electronic order for shipment
- Shipment may go only to the purchaser's residential address or to an authorized community delivery site (where applicable)



AS 04.09.470 – Package Store Delivery Endorsement

- ... authorizes the package store licensee to deliver alcoholic beverages to the location of a "social event"
 - Social event means a private, by-invitation-only event, such as a wedding, memorial, graduation, or holiday celebration
- Endorsement holder may deliver only in response to an order and may deliver only to a responsible adult, who must provide identification and acknowledge receipt in writing



• AS 04.09.470 – Package Store Delivery Endorsement Continued

- Regulatory requirements in 3 AAC 305.340(c):
 - Delivery must be between 8 am and 5 pm
 - Order must be written or electronic and receipt of delivery must be kept for one year
 - Delivery must be by a person who has successfully completed server education
 - Delivery must be at least 48 hours from receipt of payment



- AS 04.09.490 Package Store Sampling Endorsement
 - ... authorizes the holder to offer for consumption on the licensed premises at no charge a small sample of an alcoholic beverage from its inventory during a package store's stated hours of business, but not between midnight and 8 am.
 - Endorsement holder may not publicly advertise sampling activities
 - Volume limits:
 - 12 oz. of brewed beverages, mead, or cider (if the mead/cider contains *less* than 8.5% alcohol by volume)
 - 6 oz. of wine, sake, mead, or cider (if the mead/cider contains *more* than 8.5% alcohol by volume)
 - 1.5 oz. of distilled spirits



Local Government Protest

Did anything change in regards to Local Governments and their ability to protest?

- No AS 04.11.480 (Protest) has very few changes
- Applications for endorsements for new activities or expansion of premises will have the normal 60-day protest period
- AMCO notifications for license applications are going to look different going forward



Population Limits for Alcohol licensed premises

AS 04.11.400 & 3 AAC 305.900

Community populations determine how many of each license type may be issued

 This does not apply to tourism, manufacturer's, wholesale, outdoor rec, destination resort licenses, and a few others



Population Limits for Alcohol licensed premises



= 1 : 3,000 residents



= 1 : 1,500 residents

- BDLs, Club lic., Package Stores, and most others are 1 per 3,000 residents
- Restaurants are 1 per 1,500 residents
- Some licenses are exempt from population limits: bars located in hotels, airports (BDL-Tourism), and licenses that serve tourists (Seasonal REPL Tourism)



Population Limits for Alcohol licensed premises



= 1:9,000 residents

• New licenses; new ratios

 No more than one brewery retail, one winery retail, and one distillery license for each 9,000 population



Local Governments Petitioning for more REPLs

AS 04.11.405 – Petition for additional REPLs for certain local governing bodies

Additional Restaurant or Eating Place Licenses may be issued by the board if the first-class, home rule, or unified municipality

- serves as a center for commercial activity within and outside its boundary by providing goods and services to a pop. greater than the permanent resident population;
- maintains a local law enforcement department;
- Exercises planning or land-use authority; and
- Meets or exceeds the maximum limit for REPLs.



Local Governments Petitioning for more REPLs

AS 04.11.405 – Petition for additional REPLs for certain local governing bodies *cont'd*.

- Municipality may submit a resolution to the board, adopted by it's legislative body, petitioning the board under AS 04.11.405
- Resolution must prove to the board that all conditions in statute have been met (subsection (c)), and that the issuance of licenses are in the public interest
- Board holds public hearing when considering resolution



Local Governments Petitioning for more REPLs


AS 04.11.405 – Petition for additional REPLs for certain local governing bodies *cont'd*.

If the board grants a petition for additional REPL's, the board may not authorize additional REPL's, to the same municipality under this section for the following year.

Explaining Alcohol Local Options (AS 04.11.491)

A municipality can adopt a local option to <u>prohibit</u> alcohol by one of the following ways:

PROHIBIT:

- The sale of alcoholic beverages (public can still import and possess)
 - Ex: Unalakleet; Utqiagvik; Saint Mary's; Holy Cross 22 communities
- The sale of alcoholic beverages *EXCEPT* by various licensees (REPL; PS; etc.)
 - Ex: Bethel REPLs; Port Protection PS 6 communities



Explaining Alcohol Local Options (AS 04.11.491)

A municipality can adopt a local option to <u>prohibit</u> alcohol by one of the following ways:

- PROHIBIT:
 - The sale of alcoholic beverages EXCEPT on premises operated by the municipality
 - − Ex: Emmonak; Kotzebue (with distribution center) − 10 communities
 - The sale and importation of alcoholic beverages (public can still possess)
 - Ex: Hooper Bay; Noatak; Shishmaref 41 communities
 - The sale, importation, and possession of alcoholic beverages
 - Ex: Gambell; Brevig Mission; Gulkana*; Tanacross* 30 communities

Revenue Sharing of Alcohol Licensing Fees

AS 04.11.610

- Biennial alcohol license fees collected on premises within a municipality shall be refunded semi-annually back to the municipality (excluding wholesale license fees)
- Allocations may be denied "if officers of a municipality fail to actively enforce local ordinances, Title 4, laws of the United States and the state, and the regulations relating to the manufacture and sale of alcoholic beverages in the state, or fail to provide the director with a report of contacts with licensed establishments, educational activities concerning this title and local ordinances, and violations of this title occurring in the municipality, at the time and in the format as may be required by regulation adopted by the board..." (AS 04.11.610(b))



Revenue Sharing of Alcohol Licensing Fees

AS 04.11.610

- In order to qualify for refunds, municipality must submit Municipal Quarterly Reports to AMCO
- Allocations are authorized by AMCO Director on a semiannual basis (January & July)
- Once the quarterly report is approved, Department of Revenue disperses the funds to municipal governments
- The legislative intent of these funds are to enforce Title 4 and related laws/ ordinances

The sale of alcohol on Election day

AS 04.16.070 - Sales on election day

AS 04.16.070 Sales on election day

- (a) A person may pet sell, barter, give, consume, or dispose of alcoholic beverages within licensed premises
- (1) in the state on a day on which a statewide special, primary, or general election is held for the pullose of voting for a candidate is public office, until the polls have closed
- (2) in a muni. On a day on which a local election or an election is held for the purpose of voting for a can lidate for public office, until the polls are closed.
- (b) The governing body of a municipality may provide by ordinance that the provisions of this section do not apply in a municipality
