

## TIFIA / RRIF Action Plan for Alaska – Proposal

**Who:** Alaska municipalities, Alaska Municipal League, Alaska Department of Transportation & Public Facilities; PNWER RIA; Build America Bureau

When: December 6 - 8, 2023 during the Alaska Municipal League Annual Conference

Where: Dena'ina Center, Anchorage, Alaska

What: PNWER RIA will lead a work session during the Alaska Municipal League's 2023 Annual Conference to share information about the Build America Bureau's TIFIA and RRIF financing programs. This will include a facilitated discussion with participants that will lead into the creation of a TIFIA / RRIF Action Plan for Alaska. The Action Plan will aim to improve Alaska local governments' understanding of Build America Bureau financing programs, and how they could help move projects forward. Participants will take active role in designing Action Plan, including outreach strategies, milestones, and next steps for implementation. This action plan will guide RIA outreach and engagement activities in Alaska for a 24 month period.

## Objective:

- Provide introduction to financing opportunities available through the Build America Bureau, how to access information and resources about these programs, and how the PNWER RIA program can assist
- Facilitate discussion with participants about benefits and drawbacks of TIFIA and/or RRIF, including some of the unique challenges and opportunities that are present in Alaska
- Develop action plan for connecting Alaska local governments with Build America Bureau programs. This action plan will guide RIA outreach and engagement activities in Alaska for a 24 month period.
  - Overall Goal of Action Plan: Improve Alaskan local governments' understanding of Build America Bureau finance programs
